

Revising Index Methodology

In order to enhance the index investability, Shenzhen Securities Information Co., Ltd. decides to revise existing index methodology. The details are as follows:

CNI AI Selected Index: (1) Change the index name and short name to CNI AI Selected Index and CNIAISI respectively, while the index code will be changed to 980087; (2) Modify the index universe to “All A-shares and depositary receipts issued by red chip enterprises listed on the ChiNext Market of Shenzhen Stock Exchange, STAR Market of Shanghai Stock Exchange and Beijing Stock Exchange satisfying the basic criteria, and company business classified as computing and network devices, data and software services, applications and other fields related to artificial intelligence”; (3) Revise the selection method to “Remove bottom 10% securities by daily average trading value within the latest 6 months, select top 50 securities by daily average total market cap within the latest 6 months, and the number of constituents from each market is no less than 5% of the total number of the index constituents”; (4) Revise the weighting method to “Set the weight of individual constituent in the fields of computing and network devices, data and software services no more than 15%, the weight of individual constituent in the other fields no more than 3% in each periodic review and the weight of top 5 constituents no more than 60%”.
